



Copper Valley Swim & Tennis Club Babysitter Request Form

Below are the appropriate sections of the CVC Rules and Regulations that pertain to babysitting and monitoring of young children by hired childcare workers or siblings:

“Children who have not reached their 12th birthday before October 1st of the current year will not be permitted within the Pool area unless accompanied by an adult member or unless they are under responsible supervision, as defined in General Club Regulations and the person so designated is present in the pool area.

Any junior member or guest under the age of 12 shall not be permitted within the confines of Copper Valley Club without responsible supervision. Responsible supervision is considered to be provided by a person 16 years of age or older. If an adult member wishes to have his child under 12 years of age supervised by someone between the ages of 12 and 16 whom the adult member considers responsible, the adult member shall execute and submit a signed consent agreement to the president or club manager.”

I (we) understand that:

If the **babysitter** is NOT a member of CVC Club and is not entitled to any membership privileges then the babysitter may not use the club facilities unless they are providing childcare services. **All babysitters (members or non-members)** are to be with the children at ALL TIMES.

If the **non-CVC member babysitter** is on CVC property with the parent(s), the babysitter must be registered as a guest and the appropriate guest fee must be paid; all guest rules and regulations apply; including applicable fees and guest limitation policy;

Each Membership/Family is to hire its own **babysitter** for the care of its children; two or more families may not share a **babysitter at the same time;**

If my/our family will be hiring more than one **babysitter** (for different days of the week), the required form is needed for each babysitter.

I/We will review all safety guidelines, rules, and regulations of CVC with the **babysitter**; The **babysitter** MUST abide by all the rules and regulations of CVC.

The **non-CVC member babysitter** MUST register each day at the Guard House and to verify that he/she is listed as an approved **babysitter**. The member's name and his/her name must be provided to the staff.

The adult member MUST complete a permission form for his/her child/children to bring guests to CVC while in the care of the **babysitter**, and they must be presented at the guard-house or the guest(s) will be denied.
